I. Overview

Over 90 investment promotion officials and representatives of regional and international organizations participated in an interactive online seminar on facilitating investment in Sustainable Development Goal (SDG) projects organized by UNCTAD in partnership with the Mauritius Economic Development Board (EDB). The event was focused on the challenges and opportunities in the SADC region that resulted from the COVID-19 crisis. Special attention was given to the food sector, healthcare, ICT, renewable energy, and the blue economy.

UNCTAD presented the latest foreign direct investment (FDI) trends, including a steep decline in global FDI flows due to the pandemic and the serious impact of the crisis on investment in the SDGs, particularly in developing countries. The Mauritius Economic Development Board noted that the pandemic may cause the first recession in Sub-Saharan Africa in 25 years, but if managed correctly, it may eventually increase the inflow of investment in sectors that focus on ICT and the fight against climate change. The pandemic has also shown the significance of regional cooperation and may kick start reforms of trade and investment agreements within SADC.

IPA presenters highlighted the important role of ICT during the pandemic. Not only did technological access increased people's awareness of the virus and informed them on government measures, it also enabled the continuation of professional activities in times of lockdowns. The pandemic furthermore surfaced vulnerabilities in the digital infrastructure of SADC countries. This may present new investment opportunities, but as the COMESA representative noted, many IPAs in Africa are still digitally challenged and may not have the means to successfully target investors in periods of travel restrictions and lockdowns.

The seminar focused on regional cooperation with presentations by the SADC secretariat, the SADC Business Council, COMESA and UNECA. New investment opportunities resulting from a transformation of the African market due to the African Continental Free Trade Area (AfCFTA) were discussed as well as a new continental investment protocol. As part of that discussion, UNCTAD organized a session on reforms in international investment agreements and the role of IPAs in this process.

Case studies from Botswana, Namibia, the Seychelles and South Africa focused on investment in healthcare, renewables, ICT, and the blue economy. Some IPAs closely cooperate in attracting investment in these SDG-related sectors like the Seychelles Board of Investment and the Economic Development Board of Mauritius in developing their blue economies. On the second day, CINDE, the IPA from Costa Rica, made a presentation on the mainstreaming of SDGs in investment promotion. This was followed by a special session in which participants were invited to a virtual site visit to Beau Plan Smart City in Mauritius, a development project with investment opportunities in SDG-related projects, notably education and renewable energy.

During the two-day event, participants also had a chance to network and connect thanks to moderated discussions in breakout rooms. The seminar also engaged participants through online polls and Q&A sessions. Overall, the seminar was well received. In the evaluation participants reported that the training was beneficial for their work and that they would be more inclined to seek cooperation within SADC with respect to SDG investment. They also indicated that further support is most needed in the mainstreaming of the SDGs in investment promotion strategies, in the packaging of SDG project proposals, and in building pipelines of SDG related investment projects. 


